General Information about the MSC Board

Board members (Directors) serve 1-3 year terms that can be renewed. Directors can come from within or outside the Mequon Soccer Club, with new Directors requiring a simple majority vote of the existing Board for approval. Directors contribute to all aspects of managing the operations of the club, including selecting Officers, approving budgets and hiring decisions, financial/operations oversight, policy development and enforcement, and member programs and services. It is acceptable, and common, for Directors/Officers to have children in the Mequon Soccer Club. All Directors are required to recuse themselves from votes on items for which they have a direct conflict of interest, such as in decisions that directly involve their children.

The Mequon Soccer Club is presently looking for additional Directors, and also to fill Officer positions.
